Meeting Proceedings

A question may not be answered at the Meeting if it is considered not to be in the interests of the Company or the good order of the Meeting or it would involve the disclosure of sensitive information. The Chairman may also nominate a representative to answer a specific question after the Meeting or refer the questioner to the Company's website.

Shareholders will be invited to vote on a series of resolutions. It is proposed that voting on all resolutions will be by way of a poll using electronic hand-held voting devices. You can cast your vote by proxy or in person. Details of the resolutions and how to cast your vote in person or by proxy can be found in the Voting section of this website.
